Notice is hereby given that 33<sup>rd</sup> Annual General Meeting (AGM) of the Members of the Company will be held on Friday, 29<sup>th</sup> September, 2017 at 4:00 p.m. at Warden House, 340 J.J. Road, Byculla, Mumbai- 400008 to transact the business as set out in Notice of 33<sup>rd</sup> AGM. The Register of members and share transfer book will remain close from Friday, the 22<sup>nd</sup> September, 2017 to Friday, the 29<sup>th</sup> September, 2017 (both days inclusive) for the purpose of AGM.

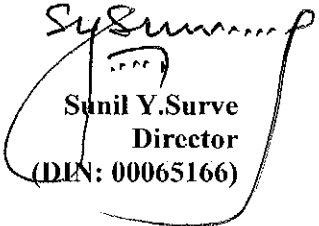
In terms of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 and Regulation 44 of the SEBI (LODR) Regulations, 2015 the Company is providing to its members, facility to cast their right to vote using an electronic voting system from a place other than venue of the meeting ("remote-e-voting) for all the business to be transacted at the 33<sup>rd</sup> Annual General Meeting.

The e-voting shall commence on Tuesday, the 26<sup>th</sup> September, 2017 at 9.00 a.m. and ends on Thursday, the 28<sup>th</sup> September, 2017 at 5.00 p.m. The remote e-voting facility shall not be allowed after the aforementioned end date and time. The cut-off date to determine eligibility to cast votes by electronic means or in the 33<sup>rd</sup> AGM of the Company is Friday, the 22<sup>nd</sup> September, 2017.

The members who have not cast their votes by remote e-voting can exercise their voting rights at the 33<sup>rd</sup> AGM. The Company will make arrangements for polling papers in this regard at the venue of 33<sup>rd</sup> AGM. A member may participate in the 33<sup>rd</sup> AGM even after exercising his right to vote through remote e-voting but shall not be allowed to vote again at the 33<sup>rd</sup> AGM.
